Description

Provide a short description of the event and its activities.

Back when the event took place, the reform of the Common European Asylum System was in full swing. If enacted, this legislative proposal would have a serious impact on the individual right to asylum. In contrast, cities across Europe are on the frontline, doing the lion's share of the integration work. In recent years, they have joined forces in city networks to advocate for a progressive, human rights-based approach to migration policy in the EU.

Already in 2021, solidarity cities and civil society organisations came together in Palermo and founded the civil society network From the Sea to the City (FSTC), as well as the city network International Alliance of Safe Harbours (IASH).

In order to include local perspectives more strongly in the shaping of EU migration policy, solidarity cities from 7 European countries met again at a two-day political discussion and networking event in Brussels on 10–11 October. Ahead of the 2024 EU Elections, the event created a space for high-ranking local politicians, city officials and city networks, including the International Alliance of Safe Harbours (IASH) and the National Association of Welcoming Cities and Territories (ANVITA) to form alliances with members of the European Parliament (6 MEPs: Greens, S&D, Renew Europe) and the EU Commission (5 representatives of DG Home). The aim of the exchange was to bring about a strategic shift in EU migration policy to be more welcoming.

The event catered to the following objectives:

- Strengthen the cooperation between municipalities and its local civil society groups (day 1)
- Promoting the exchange of best practices around the topic of migrant and refugee inclusion in European cities (day 1)
- actively including local civil society groups the projects wants to ensure an active citizen participation at the local level (day 1)
- reinforce the role of local, regional and European authorities in the European integration process. (both days, especially day 2)
- establish working channels for exchange and closer cooperation between the cities and civil society actors participating in the project and the key EU-level stakeholders in the field of migration and integration. (both days)
- widen the network IASH, creation of internal structure (working groups and coordination of the different countries) (both days)

Day 1 – Workshop Descriptions

AMSTERDAM – Inclusion without papers: The Amsterdam approach to undocumented migrants



The city of Amsterdam distinguishes between two different groups of people without official documents that reside, live and work in the city. This workshop outlined the different schemes and programmes that the city of Amsterdam offers for these two different groups, and took a look at the position of the local government within the larger framework of stakeholders, and the possibilities and limitations of law and regulations. It also addressed challenges encountered and, together with the participants, took a look at how other European cities are dealing with this topic.

BERLIN – Diversity becoming law: Berlin's path towards the Participation Act

In this workshop, we discussed the potential of enshrining participation in urban migration society in law. Berlin has passed the Act for the Promotion of Participation in a Migration Society in 2021. The workshop discussed individual participation strategies along key components of the Act, but also debated the process and challenges leading up to its adoption and actively incorporated experiences from other cities and civil society.

ZAGREB – Developing local integration policy in a challenging environment

The example of the Action Plan of the city of Zagreb was used to discuss this relation/potential conflict, and to search for suggestions on how municipalities should gain more autonomy to implement appropriate integration policies.

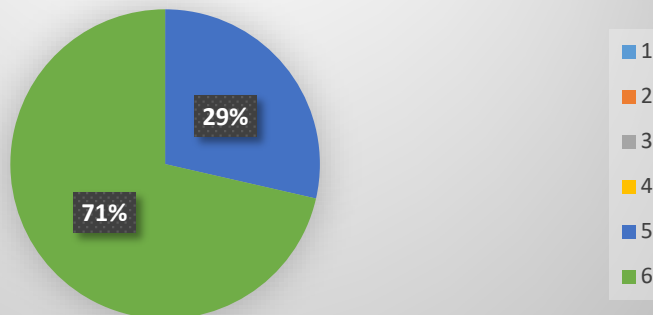




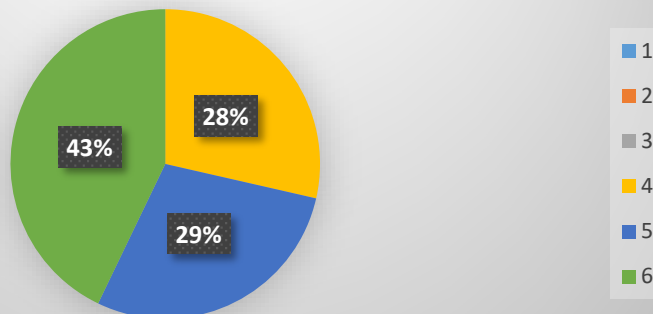

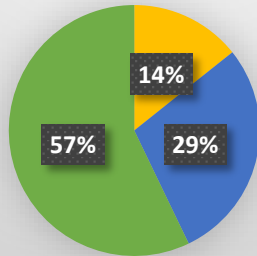

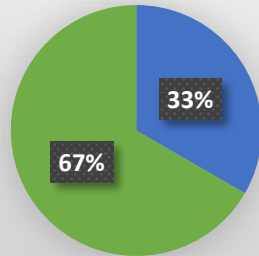
